Withdrawal deadline: 14:00 hrs GMT, Tuesday thirteen (13) days prior to the Tournament (Main Draw & Qualifying).

Freeze deadline: at 14:00 hours GMT on Thursday preceding the tournament week.

LATE WITHDRAWALS

Please note, withdrawals submitted after the Withdrawal Deadline are considered "late", and are subject to penalty under the ITF Pro Circuit Code of Conduct.

* Your first three late withdrawals in a calendar year are free and the fines will be cancelled ("withdrawal amnesty"), provided they are submitted prior to the appropriate Qualifying Sign-in deadline. From the fourth late withdrawal onwards a fine will be imposed.

Note: Withdrawals due to off-site injuries will count towards the three free late withdrawals

* Only medical certificates obtained on-site and under specific circumstances at ITF Pro Circuit tournaments will be considered valid
